Before I discuss the Pennsylvania Supreme Court ruling, a word about Trump rallies

This statement is true. It is also meaningless and one of the reasons we let our guard down in 2020.

Size is meaningless unless all the other indicators are pointing your way (which they did in 2016)

Back to Cosby:

The prosecutor said he was not found innocent. He was released on a technicality.

1) Courts in America do not find you “innocent”

2) The grounds for releasing Cosby goes to the heart of the Fifth Amendment. Right not to testify against your-self and right to counsel.

When he was a prosecutor our friend, Rudy Giuliani took down the mob with a simple but effective technique. He offered low-level players immunity from prosecution. They could no longer refuse to testify since they were not at risk of jail. He called then before the grand jury, and asked questions. Knowing if they answered the questions they would be killed, they remained silent.

Because they didn't answer questions, they were then held in contempt and put in jail. Simple but effective and 100% legal. Rather than sit in jail, many testified and then took witness protection.

Imagine if after he left office, Rudy's successor said: “I’m not bound by the agreement of immunity, and will bring charges for the crimes they admitted to in the grand jury, to which they were promised no prosecution.”

This is what happened to Bill Cosby. The prosecutor knowing he had a no case against Cosby decided to make a statement that Cosby will never be prosecuted, which forced him to testify against himself in a civil lawsuit (money only)

He gave depositions and settled with the victim for \$3 million (something the media always leaves out.)

The new prosecutor, in order to curry favor with the #MeToo crowd, brought charges against Cosby..

The Pennsylvania Supreme Court threw a red flag, and in the harshest of terms condemned the prosecutor’s disregard of the law and Constitution.

So the dropping of charges against Bill Cosby was not a technicality. It was required to restore faith in the legal system of the United States against politically motivated prosecutors.

The court also sent a message to all the judges, to stop allowing alleged victims of crimes where there was NO CONVICTION, to testify at a trial that was not charging the event they were testifying to.

When the power of the state wants to take a shot at you, they have all the ammunition. The Courts should not be helping them by abusing their power.

One more court case. **The US Supreme Court refused to hear the case of the florist who would not participate in a Gay wedding, due to her relationship with Jesus Christ.**

Folks, let me explain simply. The court is not going to allow any religious belief to allow someone to discriminate against anyone being Gay, Asian, Jewish, Black, or anything else.

The line is: **FORCED EXPRESSION.**” You cannot be forced to write “God loves gays” or “God hates gays” as that is forced expression.

Imagine going to a LGBTQ songwriter and forcing them to write a song that says if gays do not repent you will all burn in hell.

That is the dividing line. It is not so difficult and actually makes sense.
