**Ruth Bader Ginsburg said:** "...Roe was a faulty decision. For Ginsburg, the landmark 1973 Supreme Court decision that affirmed a woman's right to an abortion was too far-reaching and too sweeping, and it gave anti-abortion rights activists a very tangible target to rally against in the four decades since..."

Unlike a law that can be amended, no one had the power to amend the 1973 court created law, other than the US Supreme Court.
