Could Trump trust anyone enough to step down to await a pardon? Remember while not president he can be put in jail.

I do not see anyone ambitious enough who becomes VP to give up the presidency once they are in power.

Karl Rove told Ron DeSantis that he is not running for President of the United States. He is running to come in first or second in the early states.

Last week New Hampshire Republican Poll has trump 37% DeSantis 23%.

As other candidates drop out over money, DeSantis will pick up a few more points, and by October when people are paying attention the race could be very close.
